## FOSTER CARE VOLUNTEER AGREEMENT

The undersigned foster care provider (the "Foster Care Volunteer") agrees to accept from Cat Canton Rescue, Inc. ("CCR") animals (the "Foster Animal(s)") into his or her temporary foster care. The parties agree to the following terms with respect to any foster placement:

1. The Foster Care Volunteer will abide by the mission, rules, regulations, policies, procedures and instructions of CCR while he/she is a volunteer.
2. The Foster Care Volunteer shall provide the Foster Animal(s) with responsible care, including, but not limited to, shelter and pet supplies such as food, water and litter. CCR can provide pet supplies if needed. CCR shall provide the Foster Animal(s) with veterinary care (at our approved vets) and medicines when necessary. The Foster Volunteer agrees to bring the Foster Animal(s) to CCR's participating animal hospitals when requested for veterinary exams and other purposes.
3. The Foster Animals(s) shall remain the sole property of the CCR, and the Foster Care Volunteer understands and acknowledges that she/he does not have any right or authority to keep the Foster Animal(s) or to place the Foster Animal(s) with any other individuals.
4. Should the Foster Care Volunteer stop being a volunteer for CCR for any reason or upon CCR's request at any time, he/she will promptly return all of CCR's supplies, equipment, records, moneys, and other items in good clean condition.
5. The Foster Care Volunteer agrees to return the Foster Animal(s) to CCR upon request or sooner in the event that the Foster Care Volunteer is no longer able to adequately care for the Foster Animal(s) to CCR's standards.
6. If the Foster Care Volunteer will be sheltering or providing foster care for any of CCR's Foster Animal(s) in his/her home or business, he/she consents to CCR visiting his/her home or business upon reasonable notice, for the sole purpose of determining the on-going suitability of the premises for the care and maintenance of the Foster Animal(s).
7. The Foster Care Volunteer acknowledges and understands that there are risks associated with fostering animals with unknown medical backgrounds. Health risks can be to both humans and animals. CCR cannot guarantee the health status of any Foster Animal(s) at any time. Foster Care Volunteer should discuss with their vet (and medical doctor) any and all medical concerns associated with fostering, housing and handling animals with unknown medical backgrounds.
8. The Foster Care Volunteer assumes the risks of being bitten, scratched, injured, or frightened by the cats or kittens in connection with his/her volunteer work for CCR. CCR, it's officers, directors, and volunteers are not liable to Foster Care Volunteer for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which Foster Care Volunteer might suffer or sustain in connection with the performance of his/her volunteer activities for CCR. Foster Care Volunteer will indemnify, defend and hold harmless CCR and its officers, directors, and volunteers from and against any claims or losses in connection with my gross negligence or intentional misconduct in his/her performance of volunteer activities for CCR, or his/her intentional breach of CCR rules, regulations, policies, procedures and programs.

A Foster Care Agreement must be in effect before any Foster Animal(s) will be released to the Foster Care Volunteer.

This Agreement represents the entire understanding between the parties and any modifications must be made in writing and signed by both the Foster Care Volunteer and CCR.

**ALL FOSTER PLACEMENTS ARE SUBJECT TO APPROVAL OF CCR, ARE AT THE SOLE DISCRETION OF THE DIRECTOR OF ANIMAL CARE AND MAY BE TERMINATED AT ANY TIME.**
